S.No	PORTFOLIO	POSITION	PORTFOLIO AUTHORITY
1	Muhammad XII (Boabdil)	Emir (Sultan) of Granada	Commands all armed forces, Final arbiter in matters of law and justice, Appoints or dismisses all governors, judges, and ministers.
2	Abu al-Qasim al-Mulih	Vizier (Chief Minister)	Coordinates all administrative branches — finance, correspondence, justice, defense, Advises the Emir directly; manages the day-to-day running of the state
3	Ṣāḥib al-Qalam wa al- Qubba	Ḥājib (Chamberlain)	Controls physical and bureaucratic access to the Sultan, Oversees palace security and the internal court hierarchy
4	Ibn al-Khatib	Head of Chancellery (Dīwān al-Inshā')	Drafts, seals, and archives all royal correspondence, Oversees scribes and secretaries responsible for diplomatic and legal documents
5	Ṣāḥib al-Marsā	Qāʾid al-Baḥr (Naval Commander)	Oversees fleets based in Málaga and Almería, Responsible for defense of maritime trade routes and harbors
6	Yusuf ibn Komasha	Governor of Málaga	Maintains local defense and law enforcement, Oversees taxation, justice, and trade in the region, Commands garrisons and reports to the Vizier and Emir.
7	Sayyid ibn al-Asad	Governor of Almería	Maintains local defense and law enforcement, Oversees taxation, justice, and trade in the region, Commands garrisons and reports to the Vizier and Emir.
8	Qāḍī Abū Bakr al- Gharnāṭī	Chief Judge of Granada	Head of the sharī'a courts across the Emirate, Appoints and oversees local qāḍīs (judges)

S.No	PORTFOLIO	POSITION	PORTFOLIO AUTHORITY
9	Nāẓir Dīwān al-Kitāba	Chief Scribe	Handles royal decrees, transcribes court records, and maintains archives
10	ʻAli ibn Faraj	Commander of the Alhambra	Controls the garrison defending the Emir's palace-fortress, Responsible for palace and city defense, arms stockpiles, and fortifications, Acts as security chief for the royal family.
11	Amīr al-Khayl al- Mujannaha	Amīr of the Cavalry	Commands the Emirate's elite horsemen (the fursān), its most important military branch, Responsible for mobilization, discipline, and deployment of cavalry forces in wartime.
12	Qā'id al-Rabāṭ al-Aʻlā	Military Overseer of the Frontier	Manages border defenses, fortresses, and frontier garrisons, Collects intelligence on Castilian troop movements and Christian incursions.
13	Ibn Farkhun	Mufti of Granada	Provides binding or advisory rulings on matters of sharfa and state policy.
14	Abu Sa'id Khalid al- Kashmiri al-Afdal	Chief Tax Collector	Collects land tax (kharāj), poll tax (jizya on non-Muslims), trade duties, and customs.
15	Ṣāḥib Bayt al-Māl al- Muwaḥḥad	Royal Treasurer	Manages the Bayt al-Māl (state treasury) — revenue, war funds, royal gifts, Approves disbursements for military, administrative, and construction expenses.
16	Ibn Hajar al-Haytami	Royal Confessor / Preacher	Advises the Emir on personal conduct and religious matters, Acts as an intermediary between court and populace through religious messaging.

S.No	PORTFOLIO	POSITION	PORTFOLIO AUTHORITY
17	Ṣāḥib al-Istiblāl al- Malakī	Ṣāḥib al-Khayl (Master of Horses)	Maintains the Emir's warhorses, breeding programs, and cavalry supplies, Oversees logistics of army mobility — fodder, saddlery, stables, and transport.
18	Local Nasrid Judge	Qāḍī of Málaga	Adjudicates civil and criminal cases per Islamic law, Supervises local qāḍīs in nearby districts.
19	Ṣāḥib al-Ḥisba wa al- Niẓām	Inspector of Markets (Muḥtasib)	Enforces fair pricing, honest weights and measures, and sanitary standards in bazaars.
20	Ṣāḥib al-Barīd al- Malakī	Official Messenger (Barīd)	Manages dispatch riders and correspondents across the Emirate, Transmits royal decrees and reports between the capital and provinces.
